
# **Guide to Registering on the F.I.T. Platform**

#### a) Registration for Students and Employees:


If you have already completed your enrollment and received your Hohenheim user credentials, you can log in directly using the Hohenheim login.




Figure 3: Hohenheim Login


During your first login, you will be asked once whether you agree to your user data being forwarded to the service weiterbildung.uni-hohenheim.de.

Figure 4: Registration for External Participants






Click on "Register" to proceed.

After registration, a form will appear for creating an external account. Please complete this form with your personal details and choose a secure password. Finally, you must agree to the **data protection and participation terms**.


Figure 5: Privacy Policy and Terms and Conditions of Participation

Figure 7: Select an Event




### 4. Event Registration




To participate in an event, simply click on "Register here". Your previously saved user data will automatically appear in the registration form.


Figure 9: Registration via the Waiting List
